If a sheep loses an ear tag, you may re-tag the sheep with a different tag number and keep this information in your flock records as required by USDA regulations. However, continue to use the sheep's original ear tag number (as recorded on its FBA Certificate of Registry) for the purpose of registering its offspring. The FBA will furnish suggestions for tagging and/or identification upon request.*

*Docked Tails: Finnsheep with docked tails will not be registered. The tail is a distinct characteristic of the animal's/breed's purity.*
