### Chief Shepherd's Message

#### PART OF THE BIG PICTURE

I have always enjoyed reading the President's letter for the associations I am part of as well as articles like Clark Bredahl's in the "The Shepherd" magazine. It always gives me another perspective on topics that have at least some importance to me.

I feel like I am just a small breeder like the majority of our breeders. I don't feel like I have any significant impact in the Finnsheep community or the sheep industry as I just have a small herd. I know some of you may look at the size of the flock I maintain and think it isn't small. We have about 120 breeding ewes (not all purebred Finnsheep), which brings us on a good year, about 275 lambs for breeding stock or market. So, no it isn't just 10 or less lambs like some of you might have, but 275 a year doesn't seem like an impactable amount knowing over 2 million lambs are processed in the USA each year, but the reality is everything we do has a ripple effect and often one that we vastly underestimate.

I fully believe the sheep industry in the United States has much more potential than is being utilized. I think almost any consumer of lamb, if asked if they prefer for their lamb meat to be imported or USA grown, would say they prefer USA grown, yet supply doesn't meet demand and there is a lot of imported lamb. Having demand for the lamb produced opens the door for profitability, even for those that don't send lambs to market.

Profitability leads to growth. If you think about the big corporate giants, they are big because they were doing something profitable, and invested in growing to be able to do more of what was profitable. If they weren't turning a profit, they wouldn't be able to maintain their size. This is exactly true with farmers, especially livestock farmers. Livestock needs to eat and if there isn't money coming in to pay the feed bill, then the herd size needs to get smaller.

There have been many sheep breeds here while trying to figure out what works for us. Finnsheep have stayed as when I have taken a look at the books and what is working, I have seen that quality Finnsheep ewes pay for themselves and put money in the bank. I have also seen where non-quality ewes will affect my profitability for years to come. Luckily for the most part it can be simple, Finnsheep that meet our breed standard tend to be profitable for us. They have a variety of strengths that allow us more than one way to secure income from them.



One thing I saw with one of the other breeds we used to raise was that the producers of that breed worked together. There were lambs that were popping up with a genetic deformity, they as producers didn't isolate the line or think of it as a "bad" line, but instead worked together and got researchers involved to identify if there was a genetic component to the issue and be able to test for it. They found a way to identify the specific problem and not have to eliminate whole lines because they might have or might be carriers for the issue. Producers working together in a common direction can have a significant impact for their breed.

Finnsheep are an amazing breed because of all that they are good at. For me it is an honor to be a breeder. As a breeder I have the opportunity to affect another person's flock and their outlook on Finnsheep. If I am selling to a new shepherd that hasn't experienced Finnsheep before, I am in the

position that what I present, and sell is what is believed to be what Finnsheep are. If I am selling to a fellow experienced Finnsheep shepherd, there is no greater feeling than them taking pride in my breeding decisions and having success because of their use of the genetics I provided them.

To be sustainable, we as Finnsheep breeders need to offer a quality, consistent product to the market. While we all have different flock goals, we can still have a consistent breed that boosts consumer confidence. We do this by defining what makes a Finnsheep a Finnsheep and take those defining characteristics into consideration as we make breeding choices. By doing so, even when the characteristic may not seem all that significant to us as individuals, we come closer to that consistency. We establish ourselves as a breed that can be counted on year after year.





Regardless of our flock size, our flock goals, and our flock management philosophies, we must make sure we put our best sheep forward. If we communicate and share our ideas on what the Finnsheep breed stands for and lift each other up, celebrating successes and overcoming problems, as we strive to be better shepherds of our Finnsheep we will all be more successful. Each thing we do may seem like just one sale or one lamb produced, but each has a ripple affect much larger than we realize. Realizing the magnitude of what we do is something I have to remind myself of each time I make decisions here on the farm, and something no matter how good we are at it, we can all likely improve on.

#### Haley Campbell

Hello! My name is Haley Campbell, and I am looking to become more involved in the Finnsheep Breeders' Association to further a breed that I have become very passionate about. My involvement in the sheep industry as a whole began almost 4 years ago with my now husband and his flock of sheep, consisting of purebred Texels and commercial crossbred ewes. He experimented with Finnsheep as well; he used a Texel ram on Finn ewes to produce well-mothered, heavily-muscled offspring – and lots of them! This is when I fell in love with the Finnsheep. ## Notes from the Board

2023 Has been a crazy year for the board! Here is a recap:

- Changes to the board: In January, Elizabeth Gossner resigned from the board and recommended Laura Timney in her stead. Laura was appointed as a new board member to complete 2023, until the membership could vote in a new leader. In July, Ashley Hoffman resigned as board president. Catherine Precht was appointed as the interim president until the next annual meeting.
- COI calculator: Officially up and running!
- Short Tails: Will be distributed only in digital format in the future. If a physical copy is desired, people are welcome to pay for one to be printed and sent to them. The Hall of Fame nominee each year is entitled to a hard copy of Short Tales with their HoF entry, free of charge.
- IFR registered sheep: Cannot be granted FBA papers unless the pedigree is traced back to the original FBA registration for each ancestor, to show purebred status.
- Code of Conduct: The website was updated so that each document or form submitted by our membership includes a checkbox of agreement with the Code of Conduct.
- Issues with the Associated Registries more on pages 10 and 12.
- Three spots on the board will be voted on at our annual meeting - nominations are currently open! See page 8.

- Website Pictures: The purpose of the FBA website is to promote the Finnsheep breed as a whole - not specific breeders. Therefore, photos used on the FBA website must be used without photography credit. Of course, this will be communicated in writing when the photos are submitted and before any changes are made to the website. Photos cannot be used without permission.
- Annual meeting: The annual meeting will be on December 9, 7PM Eastern, via Zoom. The physical paper notice - printed and sent by Associated Registries - did not print properly and was missing part of our logo as well as the date. The Board emailed a separate notice to the membership.

## Associated Registry

The Associated Registry is a third party contractor who handles registrations, finances, mailings, and more for the FBA.

1) We have not been getting regular financial statements, despite promises from them.

2) The printed mailing for the annual meeting notice was missing ink and critical information.

3) The breeder's directory is consistently wrong.

Please come to the annual meeting to discuss a solution!!

#### Treasurer's Report

The Associated Registries did not provide an annual financial report for our annual meeting last December, 2022. The board asked ahead of time for these year-to-date financials to be delivered by December 1st, and the Associated Registry responded that we would have it by November 23rd. It was not on time for our annual meeting on December 11th.

There was no treasurer's report for most of this year. In May, we again requested monthly itemized financial statements. AR promised to send them monthly by the 10th of each month. There was no report provided in June or July, June July and August were provided in August. The September & October financial statements were on time.

#### Advertising

We are currently advertising in the Shepherd and in the American Sheep Industry News magazine.

There was an overage with the Shepherd last year, (caught by the Magazine's internal auditors) so this year's bill has been small.

\$1836 was spent on our ad in The Shepherd in 2022, and the FBA has a credit of \$1,350 from the 20 months of being overcharged (\$67.50 of overage per month.)

#### Breeder's Directory

There are discrepancies between the member list and the breeders directory. Many members paid for a breeder's directory listing and have not received a listing. Others have a directory listing without an active FBA membership. There are also issues with the photos.



### Crossbred Registrations

It has come to our attention that a small number of registered animals were mis-registered over the last several years. A small number of breeders had multiple animals this affects, and we have begun contacting them as we get more information. These were found during a recent audit done by members of our board after a discrepancy was brought to our attention. We do not expect this to affect a majority of members, as some of these were from offspring over 10 years ago, many with no further offspring. Most mistakes done when registering (either mis-labeled by Associated Registries, or the breeder) were caught early on by the breeders who registered their animals and would have been rectified immediately.

We are taking steps (tracking lines etc.) to identify any potential offspring this still affects, and we are expecting the breeders of any subsequent offspring to be responsible for contacting those who may have unknowingly purchased affected animals from them. We are assuming this was done in error and the FBA and Associated Registries have made it a priority to identify and correct these mistakes immediately.

We have taken steps to monitor this situation with regards to the mislabeling and registering of unregisterable animals who received papers from Associated Registries. For those who have since registered offspring from this affected line/lines we will look at those on a case by case basis, and get appropriate registrations to reflect the true lineage. Some animals were registered with no purebred FBA registered sire or dam, and those animals were ineligible for registration. The members of the board are treating this with the utmost importance and want to reiterate this was an extremely small number of animals.

To help prevent any further mistakes we are publishing a registration SOP(standard operating procedure), which will detail how to complete each part of the registry. One of our board members has offered to host a live zoom meeting to show new members and anyone needing assistance on the proper way to fill out both online and paper registrations. This will be advertised once the date is chosen.

As a reminder, it is the responsibility of breeders (sellers) to check that registrations are submitted correctly as well as recorded correctly. This should be done by physically checking registrations once papers are received, and can also be done by verifying paperwork in the online database once updated. Each member must sign their form indicating they are registering animals true lineage to the best of their knowledge at the time of registration. We are all accountable for our integrity, as individuals and a membership as a whole. Thank you,

Donna Putnam - Spinning Sheep Fiber Farm

We are Donna and Bob Putnam, refugees from urban life. For each of us, the first 59 years had been spent in various large metropolitan areas, but in late 2013 we finally had the opportunity to escape. We'd been assisting various farmer friends with odds and ends of chores, but owning and operating our own small farm became a dream and is now a wonderful experience.

After much research, Donna decided on Finnsheep. Our beginning flock of four ewes, a ram, and a couple of wethers, quickly grew. Since Donna is a fiber artist, we started focusing on wool quality. Over the years, we have developed a wonderful line of wool genetics, 21-25 microns, that make handspinners quite happy. Along with wool production, we wanted to be able to pass our genetics on to other flocks. Toward that end, we worked to only use and sell the best breeding stock. Although all of the lambs are cute, not all meet our standards as future breeders.

Besides producing very soft yarn, Finn wool is great for felting. The wool from Finns felts faster than many other breeds and has a lovely, drapey hand. This makes it perfect for many products from the finest wearables to lovely décor items. Here at Spinning Sheep Fiber Farm, we focus on natural colored wool.

People often ask if it takes dye well, and the answer is a resounding yes. White will give the clear, exact colors that some folks want. The grays, of all shades, and browns take the colors to a different level, providing different hues that are not obtainable using the white wool.



Time on the farm is broken into seasons – breeding, shearing, lambing, shearing, sales, and maintenance. Each of these times comes with its own rewards and problems. Nothing makes the heart happier than seeing the lambs doing their races at dusk, or the piles of fresh fleece, warm, beautiful, and soft, at shearing time. Seeing these things happen on a Finnsheep farm makes it all the more amazing.





Within our small flock, Hyacinth is considered one of our super ewes. This SEVEN year old ewe kicked off October with a bang, lambing unassisted in the field on an unseasonably warm afternoon, for the SECOND time in 2023. Yes, for the second time, exactly 200 days apart. While this is not uncommon for ewes kept in high production breeding programs, it is a first for our flock. While we typically do not plan for ewes to lamb twice in a year, both spring and fall, our late ram, Huck, had a bit of an unintended rendezvous with the ewes in early May. Clearly, although brief, it was effective.

Hyacinth is a super producer of milk, both in quantity and quality, despite only having one functional teat due to a case of mastitis in her early years. This hasn't stopped her from raising exceptionally nice lambs with the highest growth rates in the flock. We are so grateful to Elizabeth Kinne Gossner of Stillmeadow Finnsheep for entrusting us with this grand ewe when retiring from her decades of breeding Finns. Hyacinth has already had an impact on our small flock, giving us the spectacular Sunflower last year who was retained. We have big hopes for her legacy here! - Johanna Hunt
