
Chief Shepherd's Message

A TIME TO GET INVOLVED

Earlier this summer my husband and I attended the educational opportunities put on by NSIP. One of the educational topics touched on the importance of being part of sheep organizations as a shepherd. The more I thought about the subject the more it inspired more ideas about how important it is to be involved.

There are both active ways to be involved and inactive ways. A few active ways can include being on the board of an organization you are part of, locally promoting lamb and sheep products, or talking about lamb and wool production on social media platforms. The list goes on and there are many other ways you can actively be involved. Inactive ways you can be involved are being part of a sheep breeders association (like the FBA) or your state lamb and wool association. Here too there are many other inactive ways you can be involved.

When you are part of organizations you are counted. For example, when you are part of your state lamb and wool association you are counted as a member/producer of lamb and wool. It allows the organization to lobby to your state government for things that will help shepherds and say they are speaking on behalf of the members/producers. It gives them a count of sheep producers they can factually say would be helped or impacted by legislation. Being part of your state lamb and wool association also usually gets you a membership with the American Sheep Industry. This allows representatives from ASI to lobby on behalf of all sheep producers in Washington DC. When there are 500 members, it doesn't look like funds will impact or be utilized in a way that will impact a measurable part of the population, but if there are 50,000 members it has a bigger reach.

Sometimes when things affecting the sheep industry are not in our state or region it seems like there isn't a lot we can do. One example that is going on right now that does affect each of us either directly or indirectly is the proposal to not allow animal processing in the city limits of Denver, which would require the shutting down of the lamb processing plant that is within city limits. Now I know some of our members don't sell lambs to market nor do they want any of their lambs going to market so they may think this doesn't really affect them, but the reality is that if those of us that do sell our lambs to market aren't able to, we are going to be looking to sell to the same

customers you do because reality is most of us don't plan on keeping everything we raise and we need to find a way to move them off our farm. Simple supply and demand is that there will then be many more sheep to sell to those customers and the price will go down. When ASI is lobbying against the proposal that would shut down the plant in Denver it is helpful to be able to have bigger numbers that say how many producers it will affect. Same is true for opportunities for grants and so on. Though I think many of us would like to be able to do more, being a member or part of organizations like ASI is one thing we can do to help. The other part is when you are part of your state lamb and wool association they usually offer learning opportunities that can help you be more efficient and/or more profitable.

Sometimes all we can do to be involved is to be inactively involved, but other times we are able to take a more active role in being involved. Yes, it is important to have numbers so that those that can speak on our behalf are able to do so and include us in the count of people they are speaking on behalf of, but it is also important to have producers that are willing to be actively involved. For example, our board of directors is intended to consist of 7 members per the constitution. Each person brings a different perspective and a different background to conversations. Having a smaller group of board members



gives less different experiences and background. When trying to make the best decisions for the membership maximizing the experience and knowledge of those making the decisions usually results in the best outcome for all involved. Back to the Basics - Parasite Management

Dr. Scott Bowdridge, a Professor of Food Animal Production at West Virginia University will be kicking off our annual meeting with a back to the basics of parasite management presentation. If you own sheep you deal with parasites.

A little background about Dr. Bowdridge

Dr. Bowdridge has developed a research program to investigate immune responses in sheep to gastrointestinal nematode parasites. He earned his doctorate from Virginia Tech studying immune responses of St. Croix sheep to *Haemonchus Contortus* and also spent time studying specific immune mechanisms during intestinal parasite infection in a NIH funded postdoc position at the New Jersey Medical School.

Notes from the Board

Contract renewal with AR

Though the board is working on an alternate option for our registry services we are still utilizing the services of AR. This year is our contract renewal with AR. The transaction fee that AR is charging per transaction is going up to \$4.50 per transaction, from \$3.75. The board had discussion regarding what this means for what members should pay for the transactions. It was decided that the purebred registration would stay at \$8.50, but that the transfer fee and crossbred registration fee would go up by \$0.75 each to match the increase that AR has made.

Update on Moving away from AR

As we expressed previously Doug from Mountain Niche is working on building us an admin portal to be able to process our registrations and memberships online. He is still working on this and the board has not seen a testing site as of yet. So no real update at this time other than we are just waiting for the next step.

Finnsheep in Science - News from the UK

Very many thanks for your comprehensive and interesting website concerning Finnsheep in the United States.

As part of a project in the UK for www.sheeptrust.org, we are currently analysing genome sequences of Finnsheep from the US, publicly available through the international sheep genomics consortium.

Our main focus has been/is the Herdwick sheep breed - the Sheep Trust charity was started in response to the Foot and Mouth epidemic in the UK in 1991.... (and in fact I have one ewe still with my flock, who was conceived on a hill farm in Wasdale in the Lake District 1991 - stored in liquid nitrogen born via a surrogate ewe on the 10 year anniversary in 2001.. and going strong at 13y !)

The charity is committed to developing sound science to encourage recognition of the significance and strengths of locally adapted native sheep breeds - those typically concentrated in specific geographical and environmental areas - such as the Lake District in the north west of the UK - or the marsh farmlands in the south east of the country. As part of this work we undertook some early work on genetic distinctiveness between breeds, but in recent years we are applying the greatly improved technologies of genomics. Currently this involves genomic sequencing, and as part of this wider study we are currently comparing distinctiveness of Finnsheep, Romney and Merino and Herdwick.

I hope to let you know our findings when we have processed all the data - but this was just to make contact and to thank you for your work and support of Finnsheep breed in the US.






Constitution Committee

A Tribute to Dr. Charles Parker


Compiled words of wisdom


